Historic vehicles in Europe and Overseas

General:

FIVA's Definiton:

A historic vehicle is a mechanically propelled vehicle, manufactured more than 25 years ago, preserved and maintained in historically correct condition and in the care of a person or organisation keeping it for its historic and technical interest and not using it as everyday transport.

For those vehicles FIVA, upon application, will issue a FIVA Identity Card.
