1. TECHNICAL COMMISSION DEFINITIONS OF VEHICLE CATEGORIES 2025/2026

Index of technical terms and definitions for vehicles covered by the 2025 FIVA Technical Code

- 1. **Artefact** is an object created, shaped, or modified by a human being (thus something "artificially" produced", as the derivation of the term suggests).
- 2. Original, Authentic and Genuine are considered as synonymous in our field.
- 3. Original configuration is the set-up of the vehicle when assembled as a functional unit.
- 4. **Identification or Identity of a vehicle** is determined by the manufacturer by assigning an identification number to the vehicle. Major components may also have their own numbers: chassis/frame, body, engine, transmission, differential, steering box, etc.
- 5. **Replica or Continuation** is a reproduction by the manufacturer himself or executed on his behalf. The build year as defined by the FIVA Technical Code has to be considered.
- 6. **Copy or Reproduction** is a vehicle made to the same specifications by an entity that is not the original manufacturer himself or executed on his behalf.
- 7. **Clone or Duplication** is an exact copy or reproduction of an original vehicle claiming the same identity as the original.
- 8. **Counterfeit** is a vehicle creation having an appearance and being badged like an original, but not according to the original specification.
- 9. **Fake** is a vehicle creation bearing badges of a manufacturer, who has never produced such a vehicle.
- 10. **Kit-car** is a vehicle made from new and/or used parts which are sold individually or together as a kit. It can be delivered as a kit or assembled.



2. FIVA VEHICLE AGE CATEGORIES - 2025

As a guideline FIVA has defined these following classes – they are completely optional but may be used by organisers if they wish.

All FIVA registered events may use these classes; sub-divisions are allowed

- Class A: (Ancestor) Vehicles built up to 31st December 1904
- Class B: (Veteran) Vehicles built between 1st January 1905 and 31st December 1918
- Class C: (Vintage) Vehicles built between 1st January 1919 and 31st December 1930
- Class D: (Post Vintage) Vehicles built between 1st January 1931 and 31st December 1945
- Class E: (Post War) Vehicles built between 1st January 1946 and 31st December 1960
- Class F: Vehicles built between 1st January 1961 and 31st December 1970
- Class G: Vehicles built between 1st January 1971 and 31st December 1980
- Class H: Vehicles built between 1st January 1981 and 31st December 1990
- Class I: Vehicles built between 1st January 1991 and the FIVA age limit as defined by the HISTORIC VEHICLE DEFINITION
- Class Y: Youngtimer: Vehicles between 20 and 29 years old.
