### Candidacies and Proposals for the Agenda

### Voting Delegates

The names of the voting delegate and, if appointed, one deputy voting delegate should be notified to the FIVA Office using the online form <https://www.fiva.org/general-assembly> no later than 7 days before the meeting, which is no later than **15<sup>th</sup> November 2025** (Art. 2.1 of the Internal Rules).

### Proxy

Should your organisation be entitled to vote at the General Assembly, but unable to join the meeting (even online), you are recommended to give a proxy for voting purposes to another FIVA Member in accordance with Art. 5.7.5 of the Statutes. A National Member may carry only one proxy from another National Member. FIVA must be informed of the details in writing no later than **15<sup>th</sup> November 2025**.
